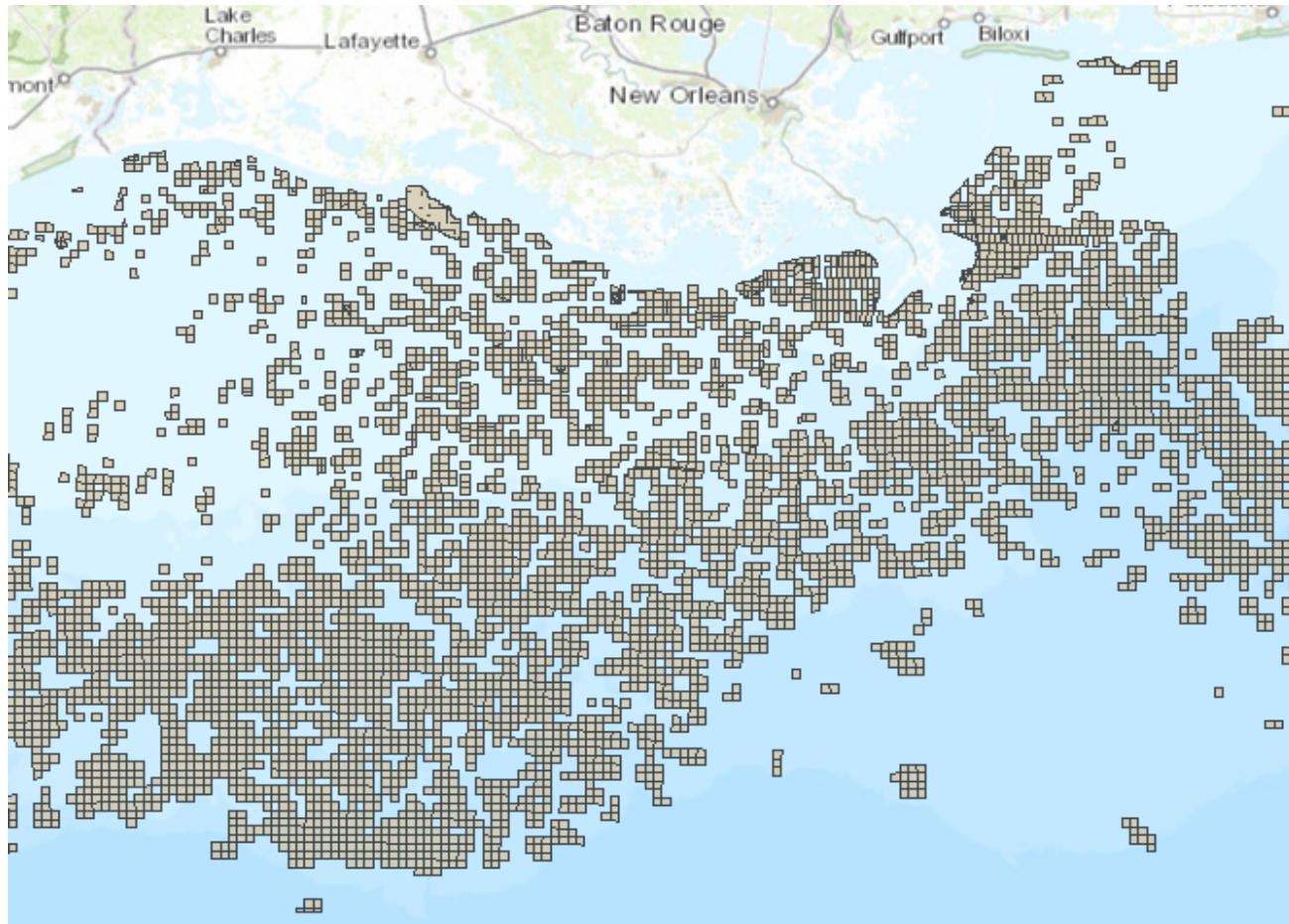

<p>A Land Professional shall not betray his partner's, employer's, or client's trust by directly turning confidential information to personal gain.</p>	<p>An engineer shall not reveal facts, data, or information without the prior consent of the client or employer except as authorized or required by law or this Code</p>	<p>A lawyer shall not reveal information relating to the representation of a client unless the client gives informed consent.</p>	<p>We all must be cautious and discreet when using information categorized as "classified" or "confidential-restricted access."</p>
<p>Avoid business activity which may conflict with the interest of his employer or client or result in the unauthorized disclosure or misuse of confidential information</p>	<p>Disclose all known or potential conflicts of interest that could influence or appear to influence their judgment or the quality of their services</p>	<p>A lawyer shall not represent a client if the representation involves a concurrent conflict of interest.</p>	<p>Business decisions should be made free from any conflict of interest. 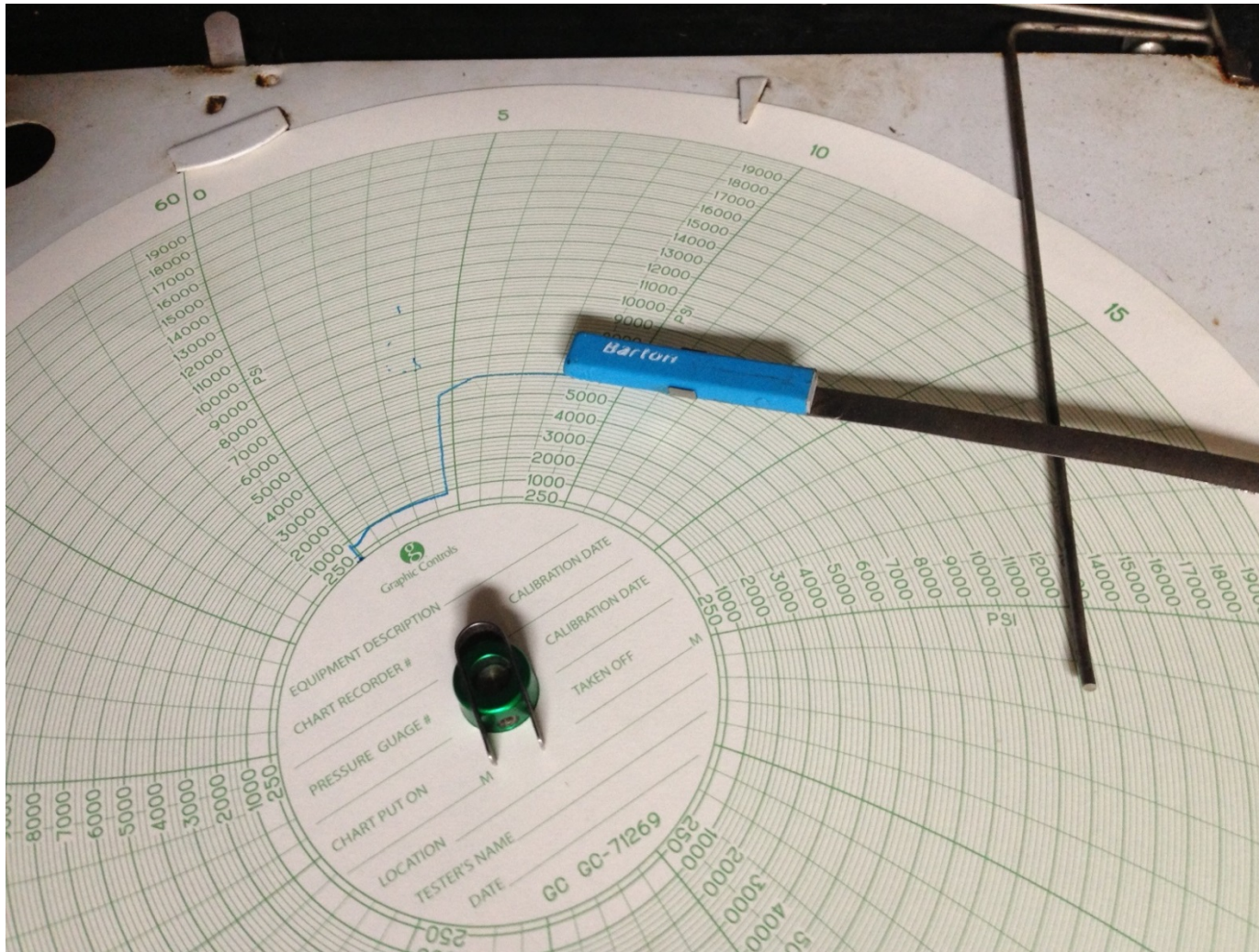


